NEW BREEDING LICENCE APPLICATION – GREYHOUND

(The managing owner of any registered greyhound bitch, or person with an authority (Form B) to breed a litter from a registered greyhound bitch, or person engaged on behalf of the breeders who has the day to day care, control and custody of a bitch used for breeding or the rearing of greyhound pups to be used for racing purposes, must hold a GREYHOUND BREEDING LICENCE.

- BE 18YRS OF AGE OR OLDER
- PROVIDE A CURRENT POLICE CERTIFICATE*
- INCLUDE A RWWA STATEMENT OF ASSETS AND LIABILITIES THAT DEMONSTRATES SUFFICIENT FINANCIAL MEANS TO CONDUCT GREYHOUND BREEDING.
- COMPLETE AND FORWARD THE COMPLETED MODULES OF THE RWWA BREEDERS EDUCATION PACKAGE*

(Note "*" Persons who have been registered by RWWA as the breeder of a litter prior to the 1 August 2011, may be exempted from these requirements and should contact the RWWA Stewards prior to application to inquire into their eligibility for exemption from these provisions)

CONDITIONS APPLICABLE TO GREYHOUND BREEDING LICENCE

Applicants must be 18-years of age or older to be issued with a GREYHOUND BREEDING LICENCE

In making application for a GREYHOUND BREEDING LICENCE with RWWA I acknowledge that any such licence issued to me is subject to the following conditions:

1. That I will at all times keep and maintain greyhounds domiciled on my premises and/or for which I am responsible in good condition and provide such greyhounds with proper accommodation, kennelling, food, clothing and veterinary attention in accordance with the guidelines herein contained.
2. That I will complete, where required, to the satisfaction of the RWWA Stewards the RWWA Breeding Competency Package.
3. That I will notify RWWA within 48 hours of the names or identity of all greyhounds domiciled in my kennels for a period exceeding 48 hours and the names or identity of all greyhounds removed from my kennels also within 48 hours.
4. That I undertake that in the event of registration being granted to me to observe the following conditions when exercising greyhounds in any public place, street or park:
 - (a) Such greyhounds shall be properly muzzled and on a leash.
 - (b) One person shall not exercise more than 2 greyhounds at any one time.
 - (c) I will ensure that a person under the age of 16 years shall not lead greyhounds for me unless such person is accompanied by an adult.
 - (d) No greyhounds shall be exercised in any public park without the consent of the Authority in control of that park.
 - (e) Observe all Government and/or Municipal lawful requirements.
5. I will permit the Stewards or Officials of RWWA to enter at any time and inspect my property and to exercise their powers under the Rules.
6. If I am charged with an offence punishable by fine or imprisonment I undertake to contact the Stewards immediately upon being charged.
7. If I have been convicted of an offence punishable by fine or imprisonment, I undertake to contact the RWWA Stewards immediately and attach to this application a copy of my current Police Clearance Certificate and details of the Court ruling in relation to the offence.
8. I shall at all times conduct and present myself in a professional and proper manner and comply with the RWWA Rules of Greyhound Racing, Official's instructions and the powers afforded to them and that failure to do so can place my current and future involvement in the industry in jeopardy.
9. I acknowledge having read and understood the said Rules, in particular in relation to the requirements with respect to the breeding matters (Rules 125-138 and lodgment of notices of service, whelping and litter registration) and further undertake to read the Official RWWA publications so as to keep myself informed of any amendments to the said Rules or any other Regulations, Conditions and Directions made by RWWA.
10. I agree to be bound at all times by the said Rules in force from time to time and any other lawful Rules, Regulations, Conditions and Directions as may from time to time be formed, made or given by Stewards or Officials of RWWA.
11. I acknowledge that in the event of becoming disqualified, my current licence is forfeited and upon expiration of the disqualification I must re-apply for a Licence. I recognize in these circumstances such application may be refused or made subject to special conditions. I will provide the Licensing & Registrations Department with written advice of any changes to the details I have advised in this application within 48-hours of the change.
12. I hereby declare that all particulars stated on this application are true and correct, that I have read all the conditions appearing in this Application and acknowledge and agree to abide by all such conditions.
13. I acknowledge that the Stewards are empowered to punish any person who makes any false or misleading statement or declaration in respect of any matter in connection with the administration or control of Greyhound Racing or any person who contravenes the conditions upon which this GREYHOUND BREEDING LICENCE is subject to.
14. I acknowledge that if I do not breed or rear a litter for a period in excess of 4 years then this GREYHOUND BREEDING LICENCE shall expire and I will be required to re-apply and meet such requirements as then required before breeding further litters.
15. I agree that RWWA may record telephone conversations with you when you contact RWWA or are contacted by RWWA by telephone line in relation to any licence or racing related matter
