2. Notwithstanding the granting of an AI Technicians license, I accept that a Steward or other RWWA official may attend to observe any activity governed by such license for the purpose of ensuring my competency and suitability to remain licensed or for any other purpose and that I may be required to provide information in relation to such activities to assist any enquiries being properly conducted by the Stewards or RWWA Officials.
3. I will permit the Stewards or officials of RWWA to enter at any time and inspect any premises used in connection to my license and to exercise their powers under the Rules.
4. I shall at all times conduct and present myself in a professional and proper manner and comply with the Rules of Harness Racing RWWA, Official's instructions and the powers afforded to them and that failure to do so can place my current and future involvement in the industry in jeopardy.
5. I acknowledge having read and understood the said Rules and further undertake to read the Official RWWA publications so as to keep myself informed of any amendments to the said Rules or any other Regulations, Conditions and Directions made by RWWA.
6. I agree to be bound at all times by the said Rules in force from time to time and any other lawful Rules, Regulations, Conditions and Directions as may from time to time be formed, made or given by Stewards or Officials of RWWA.
7. I confirm that I am aware of and agree to conduct the activities of an AI Technician in full accordance with the Rules of Racing and all regulations that apply to such activities. I acknowledge that a failure to do so may result in the cancellation of my licensed status of AI Technician.
8. I acknowledge that in the event of becoming disqualified, my license is forfeited and upon expiration of the disqualification I must re-apply for a license, and in these circumstances such application may be refused or made subject to special conditions.
9. In the event that my license is cancelled, refused, withdrawn or otherwise made invalid, I will immediately cease performing any duties governed by this license and accept that I may be liable for further punishment in the event that I do not.
10. I will provide the Licensing & Registrations Department with written advice of any changes to the details I have advised in this application within 48-hours of the change.
11. I acknowledge that the Stewards are empowered to punish any person who makes any false or misleading statement or declaration in respect of any matter in connection with the administration or control of Harness Racing. I make this solemn declaration conscientiously believing the same to be true and by virtue of the provision of Section 106 of The Evidence Act 1906.
