Acceptance Fee (\$275.00 GST Inclusive – due 31<sup>st</sup> March 2012)  
are eligible to accept for the heats of the 2012 Pearl and 2012 Diamond Classic.

**Nominations must be made on the official Continuation Form.  
A Nomination will NOT be accepted unless accompanied by the CORRECT fee.**

### CONDITIONS OF ENTRY

1. All horses wishing to start in the heats must have an Acceptance Fee of \$275.00 paid (GST INCLUSIVE) due 31st March 2012.
2. Horses may have an Acceptance payment made for a fee of \$550.00 (GST INC) between 1st April and 14th April 2012.
3. Horses may have an Acceptance payment made for a fee of \$1,100.00 (GST INC) between 15th April and 29th April 2012.
4. Any acceptance payment shall be paid by the close of business on the date advertised for such payment.
5. Horses completely paid up for will be guaranteed a start in the heats of **THE PEARL** or **DIAMOND CLASSIC**, provided the horse is qualified to race under the **Racing & Wagering Western Australia** Qualifying Standards prior to the acceptance date set down for the meeting at which the heats shall be run and a Stable Return has been lodged.
6. **THE PEARL CLASSIC** will be open to any registered colt or gelding born in the 2009/10 season (i.e. 1/9/09 to 31/8/10).
7. **THE DIAMOND CLASSIC** will be open to any registered filly born in the 2009/10 season (i.e. 1/9/09 to 31/8/10).
8. All horses nominated and paid up for **THE PEARL** or **DIAMOND CLASSIC** must be **NOMINATED SEPARATELY FOR THE HEATS** of the classic on the **DATE** which will be advertised. Payment of the futurity does not constitute a race nomination.
9. Racing & Wagering Western Australia shall have the power to deal with any matter whether or not such matter is specifically covered by these conditions. Any decision of Racing & Wagering Western Australia shall be final and conclusive and binding on all parties.
