Race 1 - Qualifying Trial/Provincial/380 (1) - Qualifying Trial - 5:45 PM

(380M): RONNIE RANGER began quickly. WESTDALE FURY & RONNIE RANGER collided soon after the start. WESTDALE FURY checked off the heels of RONNIE RANGER and collided with ROUGH AND READY on the first turn. WHISKEY LAD tailed off due to injury in the back straight. WESTDALE FURY & RONNIE RANGER collided approaching the second turn, RONNIE RANGER lost ground and collided with ROUGH AND READY, RIOT ON RUM was inconvenienced. RIOT ON RUM shifted out and raced wide on the home turn.

A post race veterinary examination revealed that WHISKEY LAD had a sore right shoulder muscle and groin and has been stood down for 10 days.

Race 2 - Qualifying Trial/Provincial/380 (2) - Qualifying Trial - 5:55 PM

(380M): SAND PATCH & MOMENT TO GIGGLE began quickly. CREATE CHAOS began slowly. SAND PATCH & MOMENT TO GIGGLE collided on the first turn. REGAL LI galloped on the heels of MOMENT TO GIGGLE on the second turn, MOMENT TO GIGGLE stumbled, CREATE CHAOS lost ground.

Race 3 - Qualifying Trial/Provincial/380 (3) - Qualifying Trial - 6:05 PM

(380M): CLASSIC STYLE & SUNSET ASHES collided on the first turn.

Race 4 - Qualifying Trial/City/520 - Qualifying Trial - 6:15 PM

(520M): DISCO STU began quickly. WESTDALE OPAL began slowly. WESTDALE OPAL checked off the heels of CRYPTO MONELLI soon after the start. CRYPTO MONELLI raced ungenerously and collided with CARTER AXELROD soon after the start and under Rule 129 was placed on a Field Satisfactory Trial. CRYPTO MONELLI checked off the heels of CARTER AXELROD approaching the first turn. COLUMBUS MONELLI & DISCO STU collided on the first turn. COLUMBUS MONELLI checked off the heels of DISCO STU, shifted out and raced wide on the first turn. WESTDALE OPAL & CRYPTO MONELLI collided on the first turn. COLUMBUS MONELLI & CRYPTO MONELLI collided on the second turn.

CRYPTO MONELLI was examined by the course Veterinary Surgeon and no apparent injury was reported.
