A post race veterinary examination revealed that SIMPLY NO DOUBT had sore right hind leg hip and thigh muscles and has been stood down for 7 days.

Stewards inquired into a report that PARIS PARMELIA had marred on the home turn and approaching the finishing line. Trainer Mr J Righetti acknowledged the report, subsequently PARIS PARMELIA has been suspended for 28 days (Cannington) and placed on a Field Satisfactory Trial under R123.

A post race veterinary examination revealed that VANDA STANLEY had right sciatic nerve soreness and has been stood down for 7 days.

SIMPLY BEAT THAT was examined by the course Veterinary Surgeon and no apparent injury was reported.

FLASHING KUNA & WATUSI collided at the catching pen. SUNSET DAISY veered out and marred WATUSI approaching the home turn. SIMPLE DIMPLE checked off the heels of WATUSI, shifted out and raced wide approaching the home turn. SIMPLE DIMPLE, WATUSI & SUNSET DAISY collided on the home turn. WEBLEC OPAL shifted out and raced wide on the home turn and in the home straight. SUNSET DAISY raced with a dislodged muzzle.

A post race veterinary examination revealed that WATUSI had a grade 2 tear in right groin muscle and has been stood down for 10 days.

Stewards inquired into a report that SUNSET DAISY had marred approaching the home turn. Kennel Representative Mr T Beckett acknowledged the report, subsequently SUNSET DAISY has been suspended for 28 days (All Tracks) and placed on a Field Satisfactory Trial under R123.

Race 10 - Grade 5/Country/275 - Grade 5 - 6:36 PM

(275M): CHA CHA MOMENT, AWESOME EXPRESS & SIMPLY WHATEVER began quickly. VANDA CHESTER, WIZARD'S FORCE & ABSOLUTE FUN began slowly. WIZARD'S FORCE & ABSOLUTE FUN collided soon after the start. EMERALD LAKE checked off the heels of CHA CHA MOMENT soon after the start. EMERALD LAKE, ALL CASHED UP & AWESOME EXPRESS collided approaching the first turn, ALL CASHED UP & AWESOME EXPRESS lost ground. VANDA CHESTER, SIMPLY WHATEVER & WIZARD'S FORCE collided on the first turn. WIZARD'S FORCE & ABSOLUTE FUN collided on the first turn.

CORINNE'S GEM checked off the heels of WESTERN DELIGHT and collided with KING OF SAXONY on the first turn. KING OF SAXONY & TELEPORT TILLY collided on the first turn. REALLY SURPRISED & FINEST MOMENT collided approaching the second turn. CORINNE'S GEM & TELEPORT TILLY collided on the second turn, TELEPORT TILLY lost ground and collided with KING OF SAXONY, KING OF SAXONY lost considerable ground. FINEST MOMENT shifted in, raced ungenerously due to injury and collided with UNIT several times in the home straight and under Rule 129 has been placed on a Field Satisfactory Trial.

A post race veterinary examination revealed that FINEST MOMENT had a grade 1-2 tear in right shoulder muscle & a sore left hind thigh muscle and has been stood down for 7 days.
