STEWARDS ADVICE: Race 6 was delayed due to the on course Veterinarian treating ESCAPE PLAN with a knee laceration injury from Race 5. Subsequently all races went back one whole race and Race 10 started at 9.20pm

Stewards inquired into the incorrect rugging of WEST ON FIRE who was engaged in Race 10.

After hearing evidence from the Rugging Official Mr T Marsden, Ms A Morgan and Handler Ms G Jovanovic, Stewards issued a warning to all individuals under R169 and reminded them of their obligations in relation to rugging the correct greyhounds.

Race 1 - Maiden/Provincial/490 - Maiden - 6:07 PM

EARLY WORM began quickly. TRENDY MISS began slowly. EARLY WORM & QUICK LADY JOSIE collided on the first turn, QUICK LADY JOSIE stumbled and lost ground. OUTSTRIDE & TRENDY MISS collided on the first turn.

BIBBULMUN BOY veered out, eased and collided with EARLY WORM & OUTSTRIDE in the back straight. OUTSTRIDE & TRENDY MISS collided on the second turn.

BIBBULMUN BOY was examined by the course Veterinary Surgeon and no apparent injury was reported.

Stewards inquired into a report that BIBBULMUN BOY had failed to pursue the lure with due commitment in the back straight. Trainer Mr E Campana acknowledged the report, subsequently BIBBULMUN BOY has been stood down for 28 days (Mandurah Track Only) and placed on a Field Satisfactory Trial under R124.

Race 2 - Maiden Series (Heat)/Provincial/405 (1) - Maiden - 6:24 PM

MITRE TUX began quickly. VACILLATE began slowly. DYNAMITE MAC & TIRAMISU MONELLI collided soon after the start. OUT MAX & TIRAMISU MONELLI collided on the first turn, TIRAMISU MONELLI lost ground. TIRAMISU MONELLI checked off the heels of DYNAMITE MAC approaching the home turn. DYNAMITE MAC & VACILLATE collided on the home turn. OUT MAX galloped on the heels of MITRE TUX on the home turn. MITRE TUX shifted out and inconvenienced OUT MAX on the home turn.

MITRE TUX was examined by the course Veterinary Surgeon and no apparent injury was reported.

Race 3 - Maiden Series (Heat)/Provincial/405 (2) - Maiden - 6:48 PM

SUPER SPY & WEST ON FIREFLY began quickly. SHOW NO MERCY began slowly. I'M THE GENERAL & FIREHOUSE MAC collided soon after the start. I'M THE GENERAL, FIREHOUSE MAC & MISS MAYA collided approaching the first turn, FIREHOUSE MAC lost ground. SUPER SPY & WEST ON FIREFLY collided on the first turn. I'M THE GENERAL, MISS MAYA & PUDDING MONELLI collided on the first turn, MISS MAYA lost ground.

FIREHOUSE MAC checked off the heels of PUDDING MONELLI on the first turn. MISS MAYA galloped on the heels of PUDDING MONELLI on the first turn. MISS MAYA checked off the heels of FIREHOUSE MAC on the home turn.

FIREHOUSE MAC checked off the heels of PUDDING MONELLI in the home straight.

Race 4 - Maiden Series (Heat)/Provincial/405 (3) - Maiden - 7:03 PM

KODJA GIRL & JACK ATTACK began quickly. EXTREME MAC checked off the heels of SUNSET SOOTY soon after the start. ROMNEYA MONELLI & ED HOCKEN collided soon after the start. SUNSET SOOTY & ED HOCKEN collided on the first turn. SUNSET SOOTY & EXTREME MAC collided on the first turn. SUNSET SOOTY checked off the heels of ED HOCKEN on the home turn. SUNSET SOOTY shifted out and collided with EXTREME MAC on the home turn.

Race 5 - Novice/Provincial/405 - Novice - 7:21 PM

KINGSHOTT & RIOT ON RUM began quickly. MAXIMUM began slowly. ESCAPE PLAN & FANCY ROBIN collided soon after the start. WAFFLES MONELLI & KINGSHOTT collided on the first turn. ESCAPE PLAN checked off the heels of WAFFLES MONELLI, stumbled, hit the inside running rail and lost considerable ground due to injury on the first turn. FANCY ROBIN checked off the heels of MAXIMUM approaching the home turn. KINGSHOTT & MAXIMUM collided on the home turn. WAFFLES MONELLI & MY LAST BABE collided on the home turn. MY LAST BABE checked off the heels of LUCY HOOK on the home turn. MY LAST BABE & MAXIMUM collided heavily in the home straight.

A post-race veterinary examination revealed that ESCAPE PLAN had a laceration of the left knee and has been stood down for 28 days.

Trainer Mr E Campana was directed by the On Track Veterinarian to have ESCAPE PLAN further examined by a Veterinary Surgeon within 24 hours.

Race 6 - Mixed 4/5/Provincial/405 - Mixed 4/5 - 7:45 PM

SENSATIONALISM began quickly. GLOBAL ROAD began slowly. BRAVO MONELLI & BENIDORM collided on the first turn. KEEPING TUX checked off the heels of WEBLEC BLISS, lost ground and collided with GLOBAL ROAD on the first turn. BRAVO MONELLI & BENIDORM collided on the first turn, BENIDORM lost ground. WEBLEC BLISS & REMEMBRANCE collided on the home turn. GLOBAL ROAD checked off the heels of BRAVO MONELLI on the home turn. WEBLEC BLISS shifted out and collided with REMEMBRANCE in the home straight.

Race 7 - Novice/Provincial/490 - Novice - 8:05 PM

WEST ON CUP, LITE MONELLI & TRIUMPH MONELLI began quickly. NO PINEAPPLE began slowly. WEST ON CUP & WEST ON WHISTLE collided soon after the start. SUNSET LOUIE & NO PINEAPPLE collided on the first turn. WEST ON CUP & WEST ON WHISTLE collided on the first turn, WEST ON CUP lost ground and collided with SUNSET LOUIE. WEST ON CUP & SUNSET LOUIE collided on the first turn, WEST ON CUP hit the inside running rail and both lost considerable ground. TRIUMPH MONELLI, COOL MYRA & SUNSET SMOKY collided on the first turn. WEST ON CUP raced wide in the back straight. NO PINEAPPLE & SUNSET SMOKY collided approaching the home turn. SUNSET SMOKY shifted out, eased due to injury and inconvenienced COOL MYRA on the home turn. SUNSET SMOKY collided with COOL MYRA in the home straight. WEST ON CUP, COOL MYRA & SUNSET SMOKY raced wide in the home straight.

A post-race veterinary examination revealed that SUNSET SMOKY had a right wrist sprain and sore left hamstring and has been stood down for 14 days.

Stewards inquired into a report that SUNSET SMOKY had failed to pursue the lure with due commitment on the home turn. Kennel Representative Mr T Beckett acknowledged the report and subsequently following the report of an injury, right wrist sprain and sore left hamstring, the greyhound SUNSET SMOKY was placed on a Field Satisfactory Trial in accordance with R125.

WEST ON COBRA & WEST ON HARMONY collided on the first turn. NAPOLEON DYNAMO & WESTDALE FURY collided on the first turn. WESTDALE FURY & WEST ON COBRA collided on the first turn. WEST ON COBRA checked off the heels of WESTDALE FURY on the home turn. NAPOLEON DYNAMO checked off the heels of WESTDALE FURY on the home turn. VANDA CHESTER raced wide on the home turn.

MISS CONDOLEEZA raced wide on the home turn and in the home straight. OPIE MONELLI & OPAL MAGIC collided on the home turn.

WEST ON FIRE began quickly. GLOBAL PLAN began slowly. JIMMY MAC, BRAND NEW ME & ENERGETIC collided on the first turn, ENERGETIC lost ground. JIMMY MAC checked off the heels of BRAND NEW ME on the second turn. WEST ON JAZZ & SON OF PRINCESS collided on the second turn. ENERGETIC galloped on the heels of WEST ON JAZZ on the second turn. ENERGETIC & SON OF PRINCESS collided approaching the home turn. ENERGETIC & SON OF PRINCESS collided on the home turn. SON OF PRINCESS lost ground due to injury approaching the finish line.

A post-race veterinary examination revealed that SON OF PRINCESS had a sore right groin area and has been stood down for 7 days.
