

# Stewards' Report

## Meeting held at Cannington on Wednesday, 7 December 2022

STEWARDS ADVICE: All trials tonight were a normal catching pen finish.

### **Race 1 - Qualifying Trial/Provincial/380 (1) - Qualifying Trial - 5:55 PM**

(380M): SWIMMING HOME began quickly. MICK WILL DO checked off the heels of EPIC HOPE and collided with DANDALUP CROSS on the first turn. MICK WILL DO checked off the heels of EPIC HOPE in the back straight. MICK WILL DO shifted out, raced ungenerously due to injury and collided with EPIC HOPE on the second turn and under Rule 129 has been placed on a Field Satisfactory Trial. MICK WILL DO raced ungenerously approaching the home turn, on the home turn and in the home straight due to injury.

A post race veterinary examination revealed that MICK WILL DO had a muscle tear in the right hamstring and has been stood down for 14 days.

EPIC HOPE was examined by the course Veterinary Surgeon and no apparent injury was reported.

### **Race 2 - Qualifying Trial/Provincial/380 (2) - Qualifying Trial - 6:05 PM**

(380M): ATHENA GIRL & SHIAN PEDRO began quickly. FIRE FLY MOON began slowly. WEDGE RUN checked off the heels of MATILDA KEEPING on the first turn. WEDGE RUN shifted out and raced wide on the first turn and in the back straight. ATHENA GIRL checked off the heels of SHIAN PEDRO approaching the second turn. ATHENA GIRL & MATILDA KEEPING collided in the home straight. ATHENA GIRL checked off the heels of MATILDA KEEPING in the home straight. FIRE FLY MOON raced wide in the home straight.

### **Race 3 - Qualifying Trial/City/520 (1) - Qualifying Trial - 6:15 PM**

(520M): MOMENT TO SHAKE began quickly. MUNGO KURT shifted in and collided with MY TIME soon after the start. MY TIME & MOMENT TO SHAKE on the first turn.

### **Race 4 - Qualifying Trial/City/520 (2) - Qualifying Trial - 6:25 PM**

(520M): MOMENT TO SHIVER began slowly. QUEEN MAZE & MUNGO MISS collided several times on the first turn. QUEEN MAZE checked off the heels of SUPERSONIC SPEED at the catching pen. QUEEN MAZE galloped on the heels of SUPERSONIC SPEED in the back straight and on the second turn. QUEEN MAZE veered out and marred SUPERSONIC SPEED on the home turn and in the home straight.

SUPERSONIC SPEED was examined by the course Veterinary Surgeon and no apparent injury was reported.

Stewards inquired into a report that QUEEN MAZE had marred on the home turn and in the home straight. Kennel Representative Mr G Crudeli acknowledged the report, subsequently QUEEN MAZE has been suspended for 28 days (Cannington Track) and placed on a Field Satisfactory Trial under R123.
