Race 1 - Qualifying Trial/Provincial/380 (1) - Qualifying Trial - 5:55 PM

(380M): NOT THE HAIR began quickly. OUR AIM began slowly. TICK TOCK MOMENT checked off the heels of NOT THE HAIR soon after the start, TICK TOCK MOMENT lost ground. TICK TOCK MOMENT checked off the heels of OUR AIM on the first turn, TICK TOCK MOMENT lost ground. NOT THE HAIR & BUTTER ME UP collided approaching the second turn and on the second turn. NOT THE HAIR & OUR AIM collided on the home turn. NOT THE HAIR & BUTTER ME UP collided on the home turn.

Race 2 - Qualifying Trial/Provincial/380 (2) - Qualifying Trial - 6:05 PM

(380M): GOLD JERRY GOLD began quickly. ALL ABOUT MARBLE & TOUCH OF TOMMY collided soon after the start. ALL ABOUT MARBLE, TOUCH OF TOMMY & LIBERTY STAR collided on the first turn. OBSESSED MUCH checked off the heels of SUNSET MIRAGE and collided with OUR BOY DOUG on the first turn. ZAC'S THUNDER eased, shifted out and collided with OUR BOY DOUG on the home turn. ZAC'S THUNDER eased, shifted out and inconvenienced OUR BOY DOUG in the home straight.

ZAC'S THUNDER was examined by the course Veterinary Surgeon and no apparent injury was reported.

Stewards inquired into a report that ZAC'S THUNDER had failed to pursue the lure with due commitment approaching the home turn. Trainer Mr M. Hine acknowledged the report, subsequently ZAC'S THUNDER has been stood down for 28 days (Cannington) and placed on a Field Satisfactory Trial under R124.
