Race 1 - Qualifying Trial/Provincial/380 (1) - Qualifying Trial - 6:05 PM

(380M): STELLA QUERN began quickly. SEND IT KYE began slowly. LOOSE WHEELS checked off the heels of STELLA QUERN and collided with YINGLUCK soon after the start. LOOSE WHEELS & SEND IT KYE collided on the first turn. YINGLUCK faded on the home turn and in the home straight.

YINGLUCK was examined by the course Veterinary Surgeon and no apparent injury was reported.

Race 2 - Qualifying Trial/Provincial/380 (2) - Qualifying Trial - 6:15 PM

(380M): MAZUMA MAYHEM & WILD WINNIE began quickly. NOBLE'S MOMENT began slowly. UNIQUE JASMINE checked off the heels of WILD WINNIE and collided with REGGAE DANCE on the first turn.

Race 3 - Qualifying Trial/City/520 - Qualifying Trial - 6:25 PM

(520M): PASSING CLOUDS & SCRAMBLE BUTTON collided soon after the start. PASSING CLOUDS galloped on the heels of SCRAMBLE BUTTON on the first turn. PASSING CLOUDS galloped on the heels of BROTHER'S KEEPER on the first turn. SCRAMBLE BUTTON checked off the heels of BROTHER'S KEEPER and collided with PASSING CLOUDS on the first turn. SCRAMBLE BUTTON checked off the heels of PASSING CLOUDS at the catching pen. PASSING CLOUDS checked off the heels of BROTHER'S KEEPER on the third turn. PASSING CLOUDS & BROTHER'S KEEPER approaching the home turn and several times on the home turn. BROTHER'S KEEPER eased, shifted out and collided with PASSING CLOUDS on the home turn, both lost ground.

Stewards inquired into a report that BROTHER'S KEEPER had failed to pursue the lure with due commitment on the home turn. Trainer Mr C. Dagostino acknowledged the report, subsequently BROTHER'S KEEPER has been stood down for 28 days (Cannington Track) and placed on a Field Satisfactory Trial under R124.
