(275M): TULLY'S GEM began quickly. SURELY began slowly. ONLY BEARD & BECKIE'S DREAM collided soon after the start. TULLY'S GEM & AMANGU collided soon after the start. MUSTANG SPARKLES & ONLY BEARD collided on the first turn. BECKIE'S DREAM, SURELY & WHAT A KNOCKOUT collided on the first turn. AMANGU & SEND IT BELLA collided on the first turn. SURELY checked off the heels of SEND IT BELLA on the first turn. SURELY galloped on the heels of BECKIE'S DREAM on the first turn. SURELY checked off the heels of BECKIE'S DREAM on the home turn. WHAT A KNOCKOUT checked off the heels of SEND IT BELLA on the home turn. MUSTANG SPARKLES & AMANGU collided on the home turn.

Race 2 - Novice/Provincial/520 - Novice - 4:35 PM

(520M): GIMLI & CARE FACTOR began quickly. TUDOR LIGHT began slowly. GIMLI & YUNDERUP MOON collided soon after the start. NOT AN OPTION & ZAC'S THUNDER collided soon after the start. TUDOR LIGHT checked off the heels of CARE FACTOR soon after the start. YUNDERUP MOON, NOT AN OPTION, ZAC'S THUNDER & CARE FACTOR collided approaching the first turn, ZAC'S THUNDER shifted out and collided with TUDOR LIGHT. NOT AN OPTION & ZAC'S THUNDER collided on the third turn.

CASINO TUX checked off the heels of LADY DAY STAR on the first turn. CASINO TUX, BAROSSA ROSE & BLAZING JOY collided on the first turn. PAD UP SONIC checked off the heels of PETITE PARTON on the first turn. CASINO TUX & BLAZING JOY collided on the home turn. CASINO TUX checked off the heels of BLAZING JOY on the home turn. PAD UP SONIC checked off the heels of PETITE PARTON on the home turn. PAD UP SONIC & PETITE PARTON raced wide in the home straight. BAROSSA ROSE checked off the heels of CASINO TUX approaching the finishing line.

BAROSSA ROSE was examined by the course Veterinary Surgeon and no apparent injury was reported.

Race 4 - Maiden/Provincial/380 - Maiden - 5:17 PM

(380M): WISE EMPEROR began slowly. SEND IT KYE, RED NED GUNDI & SEND IT ROSE collided soon after the start. SEND IT ROSE & SEND IT UNO collided soon after the start. SEND IT UNO & WISE EMPEROR collided soon after the start. HUGO GUNDI galloped on the heels of PAID IN FULL on the first turn, both stumbled and lost ground. SEND IT KYE checked off the heels of HUGO GUNDI and collided with SEND IT ROSE, SEND IT UNO & WISE EMPEROR on the first turn, SEND IT KYE & SEND IT ROSE stumbled and lost ground. HUGO GUNDI & SEND IT UNO collided on the second turn, HUGO GUNDI lost ground. SEND IT UNO galloped on the heels of RED NED GUNDI on the home turn.

Race 5 - Grade 5/Country/275 (1) - Grade 5 - 5:37 PM

(275M): JUMPING JILL began quickly. ALL ABOUT KUNA & PAD UP JASPER began slowly. ROMNEYA MONELLI & TERRAMUNGAMINE collided soon after the start. PAD UP JASPER checked off the heels of WARNE MAGIC and collided with ALL ABOUT KUNA soon after the start. WARNE MAGIC & GYPSY RUMBA collided soon after the start. ROMNEYA MONELLI checked off the heels of TERRAMUNGAMINE approaching the first turn. ALL ABOUT KUNA & PAD UP JASPER collided approaching the first turn. TERRAMUNGAMINE & JUMPING JILL collided on the first turn. WARNE MAGIC & GYPSY RUMBA collided on the first turn. TERRAMUNGAMINE, JUMPING JILL & GYPSY RUMBA collided on the first turn. GYPSY RUMBA shifted out, raced ungenerously and collided with TERRAMUNGAMINE in the home straight and under R129 has been placed on a Field Satisfactory Trial.

GYPSY RUMBA was examined by the course Veterinary Surgeon and no apparent injury was reported.

KISHKA & SHINBONER LEVI collided on the first turn. WATANABE & RUBY RIPPLE collided on the first turn. FLAMING GAS checked off the heels of IT IS MOMENTUM on the home turn. KISHKA stumbled and lost ground due to injury on the home turn. KISHKA & RUBY RIPPLE collided on the home turn. FLAMING GAS checked off the heels of IT IS MOMENTUM in the home straight.

A post race veterinary examination revealed that KISHKA had a right hock fracture and has been stood down for 90 days. The greyhound was medically stabilised and then transferred from the racecourse to a veterinary hospital for assessment and treatment under the RWWA Greyhound Injury Full Recovery Scheme.

MAGIC ASPARAGUS checked off the heels of WISE KOONAC and collided with OLIVER GUNDI & LEVI BLAZER on the first turn, MAGIC ASPARAGUS, OLIVER GUNDI & LEVI BLAZER lost ground. WISE KOONAC checked off the heels of PINT OF SPECIAL and collided with REV ON RUSSELL on the first turn, REV ON RUSSELL lost ground. LEVI BLAZER checked off the heels of OLIVER GUNDI in the back straight. MAGIC ASPARAGUS & OLIVER GUNDI collided several times in the back straight. SAGO GUNDI checked off the heels of YUNDERUP DIGGER, shifted out and raced wide on the second turn. MAGIC ASPARAGUS & OLIVER GUNDI collided on the second turn, both lost ground. YUNDERUP DIGGER checked off the heels of WISE KOONAC on the home turn. LEVI BLAZER faded in the home straight.

Race 8 - Grade 5/Country/275 (2) - Grade 5 - 6:36 PM

(275M): RED SHELL began slowly. BOOM TUX & FIRE FLY CAROLE collided soon after the start. PAD UP ASTRO & SHINBONER CAREY collided soon after the start. PAD UP ASTRO & MY NAN'S EPIC collided on the first turn. MY NAN'S EPIC & RED SHELL collided on the first turn.

Race 9 - Mixed 5/6/Country/380 - Mixed 5/6 - 6:58 PM

(380M): LIQUOR LICENSE began quickly. BAZINGA BOY & OUTSTRIDE collided soon after the start. OUTSTRIDE & WINLOCK NEWS collided soon after the start. PAD UP DIPPER & LIQUOR LICENSE collided on the first turn. CALICO JOE, SON OF FRANKIE & BLOOD DIAMANTE collided on the first turn. SON OF FRANKIE galloped on the heels of LIQUOR LICENSE on the second turn, SON OF FRANKIE lost ground and collided with OUTSTRIDE, OUTSTRIDE fell.

SON OF FRANKIE was examined by the course Veterinary Surgeon and no apparent injury was reported.

OUTSTRIDE was examined by the course Veterinary Surgeon and no apparent injury was reported.

(275M): RETHINK IT began quickly. WILD OLLIE & HUEY BLUE collided soon after the start. EARLY WORM & JONAH GUNDI collided soon after the start. MOMENT IN BONDI & RETHINK IT collided soon after the start. ADVENTURE QUEEN & MOMENT IN BONDI collided approaching the first turn. EARLY WORM, JONAH GUNDI, FIRE FLY JOANNE & WILD OLLIE collided approaching the first turn. RETHINK IT, EARLY WORM, JONAH GUNDI, FIRE FLY JOANNE & WILD OLLIE collided on the first turn. MOMENT IN BONDI galloped on the heels of EARLY WORM on the first turn. JONAH GUNDI galloped on the heels of WILD OLLIE on the first turn. ADVENTURE QUEEN, RETHINK IT & WILD OLLIE collided on the first turn. WILD OLLIE checked off the heels of RETHINK IT on the home turn.

FIRE FLY JOANNE was examined by the course Veterinary Surgeon and no apparent injury was reported.

Race 11 - Grade 5/Provincial/520 - Grade 5 - 7:35 PM

(520M): MINH SMILEY, MAXIMUM KUNA, TAHITI DREAMS & OPIE MONELLI began quickly. VENETIAN began slowly. MAXIMUM KUNA & TAHITI DREAMS collided on the first turn. TAHITI DREAMS, OPIE MONELLI & BO CRUZ collided on the first turn. MAXIMUM KUNA & TAHITI DREAMS collided several times at the catching pen. OPIE MONELLI & BO CRUZ collided on the third turn. TAHITI DREAMS checked off the heels of MAXIMUM KUNA in the home straight.

Race 12 - Grade 5/Provincial/380 - Grade 5 - 7:58 PM

(380M): AUSSIE TRICKSTER & OBSESSED MUCH began quickly. DON'T TELL DASHA & TEFLON SUNNY began slowly. DON'T TELL DASHA checked off the heels of AUSSIE TRICKSTER soon after the start. FERRERO FLYER & NOT MUCH KUNA collided on the first turn. PAD UP DECLAN checked off the heels of AUSSIE TRICKSTER and collided with DON'T TELL DASHA, FERRERO FLYER, NOT MUCH KUNA, TEFLON SUNNY & LARA LONG LEGS on the first turn, PAD UP DECLAN, DON'T TELL DASHA & TEFLON SUNNY stumbled and lost ground. DON'T TELL DASHA & TEFLON SUNNY collided in the back straight. FERRERO FLYER checked off the heels of AUSSIE TRICKSTER on the second turn. DON'T TELL DASHA galloped on the heels of TEFLON SUNNY on the second turn, TEFLON SUNNY lost ground. PAD UP DECLAN raced wide on the home turn. FERRERO FLYER veered out and marred OBSESSED MUCH in the home straight.

A post race veterinary examination revealed that FERRERO FLYER had a sore right shin and has been stood down for 14 days.

Stewards inquired into a report that FERRERO FLYER had marred in the home straight. Trainer Mr B Cook acknowledged the report, subsequently FERRERO FLYER has been suspended for 28 days (Cannington Track) and placed on a Field Satisfactory Trial under R123.
