CONDITIONS OF ENTRY

1. The series is for the best 64 greyhounds nominated, plus reserves, in the opinion of a Grading Panel. An Order of Choice may apply when determining the number of heats. **Maiden greyhounds are ineligible.** The top 25% of greyhounds in the heats will be seeded based on the Order of Choice rankings.
2. The selection process is entirely at the discretion of the Grading Panel and no correspondence will be entered into.
3. The onus is entirely upon the nominator to be aware of the conditions of entry that apply to this feature event and the lodgement of a nomination, by any method approved by RWWA, indicates full acceptance of the conditions of entry.
4. The field for the final will be selected using the RWWA Policy on Field Selection for Finals (as published). Similar principles will apply in the selection of the fields for the Consolations with the second eight qualifiers being drawn into the Perth Cup Consolation (1) and the third eight qualifiers into the Perth Cup Consolation (2). Greyhounds qualifying for the consolations have a commitment to start in those events.
5. Scratchings in this series will be dealt with in the following manner:
Heats – the reserve greyhound gaining a start will be by random ballot
Final & Consolations – the 1st Reserve (No. 9) will take precedence over the 2nd Reserve (No. 10).
6. In the event of a "No Race" being declared, RWWA reserves the right to reschedule race(s) within the series to a date to be determined and the original draw will stand, with reserves reinstated. Alternatively a ballot may be conducted [refer Rule R57].
7. The prizes offered will be awarded subject to the statements herein contained being strictly accurate.
8. The owner or the registered lessee and trainer of the greyhound nominated for this feature event must be holders of current Registration Certificates issued by the Authority or an approved registration authority controlling body as defined in the RWWA Rules of Greyhound Racing.
9. The nominator hereby certifies that they are a registered person with the Authority, or an approved registration authority as defined in the RWWA Rules of Greyhound Racing. Furthermore the nominator certifies that they are the registered owner or trainer of this greyhound, or person authorised by the Stewards to nominate this greyhound, and assume full responsibility for the correctness of the particulars in this nomination.
10. RWWA reserves the right to add, delete or amend any of the conditions of the series should it be necessary to do so notwithstanding the conditions herein contained.
