Stewards Advice: During the stir up for Race 7, WAYNO slipped its collar and broke away from the Trainer Mr Joe Dailly, jumped the outside fence and entered the track and in so doing collided with the lure whilst it was in motion. WAYNO was withdrawn by the Stewards, the lure was examined and approved for racing and a further stir up was completed for the remaining field for that race. Consequently there was a delay for Race 7 which commenced at 21.10.

Stewards inquired into the circumstances surrounding the late scratching of WAYNO, after hearing evidence from the trainer Mr Dailly, Stewards concluded that the cause was purely accidental and no further action was taken.

Stewards cautioned the Parade Steward in regards to the early arrival to the boxes for Race 10.

On 2 January 2018 Trainer Mr D Hobby advised Stewards that PETUNIA MONELLI had a chip to the top of the metatarsal area following racing on Saturday 30 December 2017.

Race 1 - Novice/Provincial/380 - Novice - 7:12 PM

(380M): OOKINAKI & HAZY DAISY began quickly. NOEL'S CHOICE began slowly. WICKED DESIRE & GOODBYE collided soon after the start. DANCE AWAY, SURE ENOUGH & DEE MINI MOUSE collided approaching the first turn. DANCE AWAY, SURE ENOUGH & WICKED DESIRE collided on the first turn. DANCE AWAY, SURE ENOUGH, DEE MINI MOUSE & GOODBYE collided on the first turn. SURE ENOUGH & DEE MINI MOUSE collided heavily on the first turn, both lost ground. DEE MINI MOUSE & WICKED DESIRE collided on the first turn, both fell. GOODBYE galloped on the heels of DANCE AWAY approaching the second turn, DANCE AWAY lost ground.

SURE ENOUGH was examined by the course Veterinary Surgeon and no apparent injury was reported.

DEE MINI MOUSE was examined by the course Veterinary Surgeon and no apparent injury was reported.

WICKED DESIRE was examined by the course Veterinary Surgeon and no apparent injury was reported.

Race 2 - Grade 4/Provincial/380 - Grade 4 - 7:36 PM

(380M): GRACE UNDER FIRE & REBEL CONTENDER began quickly. URNAIUM began slowly. HARLAN ROCKS & WILDASH NELLY collided soon after the start. REBEL CONTENDER, HARLAN ROCKS & WILDASH NELLY collided on the first turn, HARLAN ROCKS lost ground. RED HOT REAGAN & IDEAL GRACE collided on the first turn. HARLAN ROCKS & WILDASH NELLY collided approaching the second turn. WILDASH NELLY galloped on the heels of HARLAN ROCKS approaching the second turn, both lost ground. IDEAL GRACE checked off the heels of GRACE UNDER FIRE on the second turn.

A post race veterinary examination revealed that HARLAN ROCKS had abrasions and has been stood down for 5 days.

WILDASH NELLY was examined by the course Veterinary Surgeon and no apparent injury was reported.

Race 3 - Novice/City/520 - Novice - 7:52 PM

(520M): OWL PERFECT & OOKINAKI FLYER began quickly. WINIFRED MONELLI & MAGIC MONELLI began slowly. HONKY KAT began very slowly. AZALEA MONELLI, PETRIA MONELLI & BLACKBERRY NIP collided soon after the start, PETRIA MONELLI was worst affected. HONKY KAT checked off the heels of MAGIC MONELLI on the first turn. WINIFRED MONELLI & MAGIC MONELLI collided several times on the first turn. WINIFRED MONELLI checked off the heels of MAGIC MONELLI on the second turn. HONKY KAT raced wide in the back straight. OOKINAKI FLYER & MAGIC MONELLI collided on the home turn. HONKY KAT checked off the heels of AZALEA MONELLI in the home straight.

Race 4 - Free For All (s)/City/520 - Free For All (s) - 8:07 PM

(520M): ASTROZONE, TROUPER MONELLI & NEVER IN KANSAS began quickly. BUNDLES GALORE began slowly. NEVER IN KANSAS, TUXEDO BLACK & FRANCE SOIR collided soon after the start, TUXEDO BLACK was worst affected. ASTROZONE & TROUPER MONELLI collided on the first turn. TROUPER MONELLI & NEVER IN KANSAS collided on the first turn. NEVER IN KANSAS & COBRA CLUTCH collided on the first turn. BUNDLES GALORE checked off the heels of COBRA CLUTCH and raced wide on the first turn. FLYING EAMONN, TUXEDO BLACK & FRANCE SOIR collided on the first turn. TUXEDO BLACK checked off the heels of FRANCE SOIR on the first turn, TUXEDO BLACK lost ground. FLYING EAMONN & FRANCE SOIR collided on the first turn. FRANCE SOIR & COBRA CLUTCH collided at the catching pen.

Race 5 - The Miata (Heat)/City/715 - Open - 8:22 PM

(715M): MOMENT TO JIVE & BERYLLIUM began quickly. TEDDY MONELLI, STANDARD ISSUE & MOMENT TO JIVE collided soon after the start, TEDDY MONELLI & STANDARD ISSUE lost ground. NEIL MONELLI & MOMENT TO JIVE collided on the first turn. LEGIT BOSS checked off the heels of NEIL MONELLI on the first turn, LEGIT BOSS lost ground. TEDDY MONELLI & STANDARD ISSUE collided on the third turn. TEDDY MONELLI faded on the fourth turn due to injury.

A post race veterinary examination revealed that TEDDY MONELLI had a left hindleg pectineus/abductor injury and a left foreleg injury and has been stood down for 21 days.

Stewards inquired into the poor performance of TEDDY MOENLLI after it finished last in a time of 43.44 seconds. The greyhound was subsequently examined by the Course Veterinary Surgeon who advised TEDDY MONELLI to have a left hindleg pectineus/abductor injury resulting in a 21 day stand down period. Given the serious nature of the injury no further action was taken against the greyhound other than a urine sample taken for analysis.

Race 6 - Mixed 4/5/City/520 - Mixed 4/5 - 8:47 PM

(520M): MISS AMERICA began quickly. RAPID INTENTION & OCHRE KEROMA began slowly. PEPPERFIED crossed to the outside soon after the start. THAT DUDE checked off the heels of MISS AMERICA and collided with RAPID INTENTION on the first turn. RAPID INTENTION & OCHRE KEROMA collided on the first turn. OCHRE KEROMA checked off the heels of RAPID INTENTION on the first turn, OCHRE KEROMA stumbled and lost ground. RAPID INTENTION raced wide in the back straight. PEPPERFIED checked off the heels of RAPID INTENTION on the home turn.

Race 7 - Mixed 4/5/Provincial/380 - Mixed 4/5 - 9:07 PM

(380M): MIGHTY MATT, ROTTEN RENDER & MOUSE LOMAR began quickly. JUNK YARD WOLF, CHER KEEPING & MISS EMMY ROSE collided heavily on the first turn, all lost ground.

WAYNO was examined by the course Veterinary Surgeon and no apparent injury was reported.

Race 8 - Grade 5 (mid Dist)/Provincial/600 - Grade 5 (mid Dist) - 9:22 PM

(600M): CHARLIE BOY & HAUNTED TO EXCEL began quickly. PELLI & JAZZ GET ON collided soon after the start. CHARLIE BOY & ALLEN KEMPO collided approaching the first turn. PELLI & KIRK BALE collided several times in the home straight the first time around, approaching the first turn, on the first turn, on the second turn and on the third turn. PELLI checked off the heels of KIRK BALE approaching the fourth turn. SONIC MONELLI & ALLEN KEMPO collided approaching the finishing line.

A post race veterinary examination revealed that ALLEN KEMPO had a spike wound and has been stood down for 7 days.

Race 9 - Grade 5/City/520 - Grade 5 - 9:42 PM

(520M): WEST ON CHARLIE, BENNY MONELLI & COSMIC MALTEZE began quickly. DANDALUP ANNIE & SKIPPER'S TICKET collided soon after the start and on the first turn. LIMITLESS & COSMIC MALTEZE collided on the first turn. CRUISER COIN & FANTASTIC WAYNE collided on the first turn. FANTASTIC WAYNE raced wide on the first turn. DANDALUP ANNIE, CRUISER COIN & FANTASTIC WAYNE collided heavily on the second turn, all lost ground. SKIPPER'S TICKET & FANTASTIC WAYNE collided on the home turn.

Race 10 - Grade 5 Masters (Final)/Provincial/380 - Grade 5 - 10:07 PM

(380M): STINKY PETE began quickly. CADILLAC STYLE began slowly. ROCK SISTER & TRICKSTER LUMIK collided on the first turn. ROCK SISTER & TOPLINE KHALEESI collided on the first turn. TOPLINE KHALEESI & CADILLAC STYLE collided on the first turn, TOPLINE KHALEESI lost ground. SHE'S A MEANIE & HE'S OUR LACHY collided approaching the second turn. HE'S OUR LACHY checked off the heels of FAULKNER approaching the second turn. FAULKNER shifted out, raced ungenerously due to injury and collided with HE'S OUR LACHY on the second turn, both lost ground and under R71 FAULKNER has been placed on a Field Satisfactory Trial.

A post race veterinary examination revealed that FAULKNER had a left hindleg pectineus/abductor injury (groin) and has been stood down for 14 days.

Race 11 - Grade 5/Provincial/380 (1) - Grade 5 - 10:22 PM

(380M): HERE'S LINDA, BUSTER KEEPING & IT'S THE HORSE began quickly. GRIZZLE MANIA, NAPOLEON BOY & PODGE began slowly. INFRARED MOMENT & GRIZZLE MANIA collided soon after the start. WHO'S GOT STORM & NAPOLEON BOY collided on the home turn. GRIZZLE MANIA checked off the heels of INFRARED MOMENT on the home turn.

Race 12 - Grade 5/Provincial/380 (2) - Grade 5 - 10:37 PM

(380M): JARBASS BALE & SO SHIROKURA began quickly. ZIPPING FLYNN began very slowly. POKKIRI RAJA & SKETCHY MATT collided on the first turn, POKKIRI RAJA was worst affected. CHEVY SHEIKH & SKETCHY MATT raced wide in the back straight. CHEVY SHEIKH raced wide on the home turn. KOBI ROCKS checked off the heels of SO SHIROKURA in the home straight.
