DO THE BEST & VENUS MONELLI collided on the first turn. STICKY VICKI & WISE QUILL collided approaching the home turn.

A post race veterinary examination revealed DUSTY MAC has Carpal sprain left & right foreleg and Tensor Fascia left hindleg and has been stood down for 10 days.

A post race veterinary examination revealed STALENBERG has Shoulder injury right foreleg, Sartorius injury right hindleg and Pectineus injury right hindleg and has been stood down for 14 days.

Stewards inquired into a report that TRICKETT MONELLI marred in the home straight. Kennel Representative M/s S. Peterson acknowledged the report, subsequently TRICKETT MONELLI has been suspended for 3 months at all tracks under R69 and placed on one Field Satisfactory Trial.

A post race veterinary examination revealed KAL'S ALL HEART has Gracilis injury right hindleg and has been stood down for 28 days.
