JET FLYER & FUNKY FACTS collided several times approaching the home turn. WAGTAIL PIRI checked off the heels of FUNKY FACTS several times on the home turn.

A post race veterinary examination revealed that JET FLYER had truncal-lumbosacral injury/soreness, a right foreleg shoulder muscle injury, a right hindleg gastrocnemius muscle injury (calf) and a left foreleg injury and has been stood down for 10 days.

A post race veterinary examination revealed that CANYA CONNOR had a right foreleg carpal sprain (wrist) and has been stood down for 7 days.

Stewards inquired into a report that CANYA CONNOR had failed to pursue the lure with due commitment at the catching pen and approaching the finishing line. Stewards heard evidence from Trainer Mr S Withers and subsequently following the report of an injury concluded the greyhound CANYA CONNOR did fail to pursue the lure with due commitment by reason of injury. Accordingly CANYA CONNOR was placed on a Field Satisfactory Trial in accordance with R69B.
