A post race veterinary examination revealed that ALDRICH had a right hindleg gracilis muscle injury (back muscle) and has been stood down for 28 days.

PAGANONI was examined by the course Veterinary Surgeon and no apparent injury was reported.

A post race veterinary examination revealed that JERKY BOY had a left foreleg carpal sprain (wrist) and has been stood down for 14 days.

(520M): SLINGSHOT GYPSY began quickly. WEST ON HAWKEYE began slowly. BUNDLES GALORE & WEST ON HAWKEYE collided soon after the start. STARLIGHT YOYO, BUNDLES GALORE & TECHNO collided on the first turn, TECHNO fell, failed to finish due to injury and under R71 has been placed on a Solo Satisfactory Trial. FRIDA MONELLI checked off the heels of LEISEL MONELLI on the first turn. BUNDLES GALORE checked off the heels of LEISEL MONELLI on the first turn. STARLIGHT YOYO & WEST ON HAWKEYE collided on the first turn. BUNDLES GALORE checked off the heels of LEISEL MONELLI on the third turn. WEST ON HAWKEYE & FRIDA MONELLI collided on the home turn. A post race veterinary examination revealed that TECHNO had a left hindleg injury and has been stood down for 10 days.

Following a fall on the first turn, TECHNO ran back into the oncoming field, however turned around again prior to reaching the 520M boxes and made its way safely into the catching pen without causing any interference to the competing greyhounds.

In an attempt to prevent TECHNO from running into the oncoming field, T2 Trainer Mr B Marshall stepped onto the track in the vicinity of the 520M boxes. Mr Marshall was advised by the Stewards to exercise extreme caution when entering the track during an event as it may place his safety and that of the competing greyhounds at risk.

Based on their live observations and repeated viewing of the video footage, Stewards were satisfied that no greyhound sustained any interference and subsequently the All Clear was posted.
