A post race veterinary examination revealed KABUKURU had a left hindleg - pectineus/adductor injury (groin) and has been stood down for 21 days.

Stewards inquired into a report that PYROTECHNICS had failed to pursue the lure with due commitment approaching the home turn. Kennel Representative Mr G Crudeli acknowledged the report and subsequently following the report of an injury of a right hindleg - sartorius (pencil/whip) muscle injury and a 10 day stand-down period, PYROTECHNICS was placed on a field satisfactory trial under R69B.

A post race veterinary examination revealed I'M YOUR MAN has a right hindleg - achilles tendon injury and has been stood down for 14 days.

Stewards inquired into a report that OFF GUARD had marred in the home straight. Trainer Mr C Dagostino acknowledged the report, subsequently OFF GUARD has been suspended for 3 months (All Tracks) and placed on a field satisfactory trial under R69.
