SCHEME RULES APPLICABLE TO WESTSPEED STALLION NOMINATIONS

Applicable from 1 August 2019

DEFINITIONS

'**Breeding Season**' means any mare served in the 2019 calendar year as advised on the Australian Stud Book mare return.

'**Eligible Stallion**' means any stallion which stands at a Stud located within Western Australia for the 2019 breeding season.

'**Registered Owner**' means the person, persons, syndicate or combination thereof, registered with RWWA as comprising the ownership of a horse at the time the horse starts in a race. For Westspeed purposes only, where a registered lease exists, the registered owner shall mean the lessor.

'**RWWA**' means Racing & Wagering Western Australia as the Principal Racing Authority for Western Australia under the Australian Rules of Racing.

'**Stallion Nomination Fee**' is the fee payable for an eligible stallion to become a 'Westspeed Stallion' and is equal to the greater of the advertised service fee (excluding GST) or \$5,000. GST of 10% is additional to the fee payable.

'**Stallion Nomination Form**' means the form for nomination of an eligible stallion, which should be duly completed and signed by the nominator and forwarded to RWWA by **4pm on Thursday 11 July 2019**, accompanied by the stallion nomination fee.

'**Westspeed Nominated Horse**' means a horse nominated by both the Breeder and Owner in accordance with the applicable scheme rules.

'**Winner**' means the official winner of a given race as declared by the RWWA Stewards. In the event of more than one participating horse being declared the winner of a race by way of a dead heat, then the race bonus shall be shared by the registered owner of each of those horses in accordance with their level of Westspeed subscription.

STALLION NOMINATIONS

1. An eligible Stallion becomes a **Westspeed Stallion** for that breeding season on payment of the prescribed stallion nomination fee and acceptance by RWWA.

ADDITIONAL OWNER BONUS

2. A Westspeed nominated horse that is also sired by a **Westspeed Stallion** in the 2019 breeding season and is the winner of a Tier 1 race (currently advertised stakes of \$50,000 to \$100,000) shall receive an additional owner bonus of **\$16,500** for each Tier 1 race win in that horses two-years-old and three-years-old seasons and in races of 1750 metres or further at four-years of age. A GST gross-up will apply where applicable. For clarity, the additional bonus payable under this clause is only applicable if the horse is already fully Westspeed nominated by the Owner.

A deduction from the above advertised bonus amounts of 6% and 3% will be paid to the Trainer and Jockey respectively.

The race bonus does not constitute any part of the prize money payable under the Australian Rules of Racing for a designated race and it is a condition of any designated race that the race bonus is not considered a prize under AR 1.

EXCLUSIONS, VARIATIONS & TERMINATION

3. Notwithstanding any other rule, RWWA may, without reason or cause being shown and without correspondence being entered into, at its absolute discretion:
 - (i) Refuse to accept lodgment for any nomination forms or fees.
 - (ii) If pursuant to Westspeed rules, RWWA refuses to accept the lodgment of any forms or fees for an eligible stallion, then RWWA shall return to the nominator any fees previously lodged with RWWA for that stallion.
 - (iii) Withhold payment of the race bonus until:
 - (a) satisfied that each eligible person is entitled to receive their respective proportions of the race bonus under the Westspeed rules.
 - (b) satisfied that the qualified horse has returned a negative result to any swab taken by the Stewards pursuant to the Rules of the Racing.
 - (c) satisfied that there has been no breach of the Rules of Racing.
 - (iv) Determine at any time during the period of the Scheme, any amount of money payable to the connections as a race bonus, in such proportions as RWWA may prescribe from time to time by publication in the Thoroughbred Racing Calendar.

RWWA NOT LIABLE

4. RWWA and its Board, Agents, Employees and Officials shall not be liable for any loss or damage of any kind whatsoever, caused by any of their respective acts or omissions, whether negligent or not, in the administration of the Scheme.
