Directives: 1. Immediately a Standardbred horse enters or leaves a trainers care he/she shall lodge a Stable Return and Notification of Gear or a HRA Form R25A. 2. Immediately a Standardbred horse is gelded, the person under whose control the horse is at the time shall notify RWWA by lodging a Stable Return. 3. When a decision is made not to race or retire a Standardbred horse, the owner or trainer shall complete a form R25A within one month. 4. In the case of a horse that dies within 14 days of being entered for a race, the trainer must notify RWWA within 24 hours. In any other case, notification must be within 7 days. Failure to comply with these directives is an offence under RWWA Rules of Harness Racing. A Stable Return may be lodged by facsimile (08) 9445 3056, mailed to RWWA Harness Racing Services 14 Hasler Road Osborne Park WA 6017 or online if the trainer or owners is a registered Harnessweb user.
