

GREYHOUND RACING - CONTROL OF RACE DAY TREATMENT INFORMATION

A FUNDAMENTAL PRINCIPLE OF AUSTRALIAN RACING IS THAT GREYHOUNDS MUST RACE FREE OF THE EFFECT OF DRUGS OR OTHER SUBSTANCES.

TO ASSIST IN MAINTAINING THIS PRINCIPLE, IT IS **NOT PERMITTED TO ADMINISTER ANY TREATMENT TO A GREYHOUND ON THE DAY OF A RACE, PRIOR TO IT RUNNING IN A RACE,** (UNTIL AFTER THAT GREYHOUND IS REMOVED FROM THE RACECOURSE ON COMPLETION OF ITS EVENT)

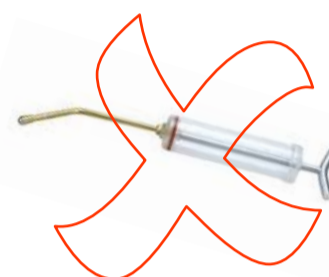
AS A GENERAL PRINCIPLE, ANY SUBSTANCE ADMINISTERED WITH THE INTENT OR HOPE OF ACHIEVING A PHARMACOLOGICAL EFFECT / THERAPEUTIC EFFECT WILL BE CONSIDERED AS A TREATMENT UNDER THE RULES.

“TREATMENT” INCLUDES:

- A) ALL CONTROLLED DRUGS (SCHEDULE 8);
- B) ALL PRESCRIPTION ANIMAL REMEDIES AND PRESCRIPTION ONLY MEDICINES (SCHEDULE 4);
- C) ANY INJECTABLE SUBSTANCE NOT ALREADY SPECIFIED IN THIS RULE, NOTWITHSTANDING THE ROUTE OF ADMINISTRATION;
- D) ALL PHARMACIST ONLY (SCHEDULE 3) AND PHARMACY ONLY (SCHEDULE 2) MEDICINES;
- E) ALL VETERINARY AND OTHER SUBSTANCES CONTAINING OTHER SCHEDULED OR UNSCHEDULED PROHIBITED SUBSTANCES:
- F) ANY TABLETS, CAPSULES OR PILLS;
- G) ANY LIQUID OR PASTE THAT REQUIRES SYRINGING INTO THE ORAL CAVITY.

ROUTES OF ADMINISTRATION OF TREATMENT NOT PERMITTED ON RACE DAY (PRIOR TO THE GREYHOUND COMPETING)

ANY SUBSTANCE ADMINISTERED TO A GREYHOUND ON RACEDAY PRIOR TO RACING BY INJECTION, PASTE, DOSE SYRINGE, TOPICAL APPLICATION OR BY INHALATION, AMONGST ANY OTHER ROUTES OF ADMINISTRATION, **WILL BE CONSIDERED A TREATMENT.**



NO INJECTIONS ON THE DAY PRIOR TO THE DAY OF AN EVENT (CLEAR DAY RESTRICTION)

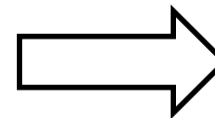
THE RED BOX DENOTES THE LAST DAY AN INJECTION CAN BE ADMINISTERED

NOTE THAT WHERE AN INJECTION CONTAINS A PROHIBITED SUBSTANCE THAT A LONGER WITHDRAWAL PERIOD MAY APPLY —SEEK VETERINARY ADVICE

PERMITTED ON RACE DAY

Only normal feeding, including any vitamin/mineral/electrolyte supplements (liquid or powder only), that can be achieved by the greyhound voluntarily eating or drinking can be considered acceptable on the day of racing.



SHAMPOOS, TALCUM POWDER & FLY SPRAYS

SHAMPOOS, TALCUM POWDER, FLY SPRAYS AND PETROLEUM JELLY (VASELINE) ARE PERMITTED.
