
The following are General Rules to be followed when applying to name a horse.

* At least 10 working days should be allowed for the processing of a naming application.

- * Apostrophes, abbreviations, initials, trade names and names of persons (living or dead) will not be accepted.
- * The Central Registrar (HRA) and the Harness Registration Officer reserve the right to reject any name.
- * All details on this form must be printed in BLOCK LETTERS.
