- 2. I acknowledge, if I am applying for a trainer's licence/permit that
 - (a) I will take out Workers Compensation insurance when I employ workers ("Workers" as defined in the Act) to assist me in my training activities (b) The training of all Horses/Greyhounds in my care will be under my personal supervision
 - (c) I will notify RWWA immediately whenever a Horses/Greyhounds leaves my control or comes under my control where it is my intention to prepare the Horses/Greyhounds to participate in trials or races and
- (d) I will permit the Stewards or Officials of RWWA to enter at any time and inspect my property and to exercise their powers under the Rules.
- 3. If I am applying for a trainer's licence/permit, I acknowledge my application will be rejected if I do not have public liability insurance.
- 4. If I am charged with an offence punishable by fine or imprisonment, I undertake to contact the Stewards immediately upon being charged.
- 5. If I have been convicted of an offence punishable by fine or imprisonment in the previous 12-months, I undertake to contact the Stewards (08 9445 5558) immediately and attach to this application a copy of my current Police Clearance Certificate and details of the Court ruling in relation to the offence.
- 6. I shall always conduct and present myself in a professional and proper manner and comply with the RWWA Rules of Racing, Official's instructions and the powers afforded to them and that failure to do so can place my current and future involvement in the industry in jeopardy.
- 7. I acknowledge that in the event of becoming disqualified, I remain bound by and subject to, the Rules of Racing for the period of my disqualification.
- 8. I further acknowledge that in the event of being disqualified, my license is forfeited and upon expiration of the disqualification I must reapply for a license. I recognize in these circumstances, such application may be refused or made subject to special conditions.
- 9. I agree to be always bound by the said Rules in force from time to time and any other lawful Rules, Regulations, Conditions and Directions as may from time
- to time be formed, made, or given by Stewards or Officials of RWWA.
- 10. I hereby declare that all particulars stated on the application are true and correct, that I have read all the conditions appearing in the Application and acknowledge and agree to abide by all such conditions
- 11. I will provide the Licensing & Registrations Department with written advice of any changes to the details I have advised in this application within 48-hours of the change.

CONDITIONS APPLICABLE TO A GREYHOUND TRAINER

Applicants must be 18-years of age or older to be registered as a Trainer.

The following are preconditions to the granting of particular categories of a trainer's licence to a person;

- has practical experience reasonably required to carry on the vocation of a trainer, including (but not limited to) experience in attendance to and performance of duties involving the handling of greyhounds at trials and race meetings
- has proper kennel facilities providing security and safety for staff and greyhounds in accordance with the RWWA Kennel Guidelines
- has adequate financial resources to carry on training activities without material risk of being unable to pay his/her debts as and when they fall due
- is of good reputation and character and is a fit and proper person to hold a licence to train greyhounds
- passes the written examination and/or interview conducted by the Stewards
- Must be a permanent resident of Australia

In making application for registration with RWWA I acknowledge that any registration which may be issued to me is subject to the following conditions:

- 1. That I undertake that in the event of registration being granted to me to observe the following conditions when exercising greyhounds in any public place, street or park:
 - (a) Such greyhounds shall be properly muzzled and on a leash.
 - (b) One person shall not exercise more than 2 greyhounds at any one time.
 - (c) I will ensure that a person under the age of 16 years shall not lead greyhounds for me unless such person is accompanied by an adult.
 - (d) No greyhounds shall be exercised in any public park or place without the consent of the Authority in control of that park.
 - (e) Observe all Government and/or Municipal lawful requirements.
- 2. That I will at all times keep and maintain greyhounds domiciled on my premises and/or for which I am responsible in good condition and provide such greyhounds with proper accommodation, kenneling, food and clothing in accordance with the standard usually provided or supplied in connection with the training of greyhounds and that it shall be grounds for termination of my licence should I fail to do so.

Without in any way limiting the power of RWWA to prescribe terms and conditions in respect of a trainer's licence, the following categories of licence to train are, unless otherwise determined by RWWA, subject to the conditions specified:

Trainer Licence – T1:

- Permits a person to be in control of or train that number of greyhounds for which they are able to provide Controlling Body and local council approved accommodation and facilities for
- Has had at least 12 months experience as a trainer under a current T2 or its equivalent in another racing jurisdiction
- Has demonstrated considerable success in training greyhounds to criteria set by RWWA

Trainer Licence – T2:

- Permits a person to be in control of or train a maximum of ten (10) greyhounds unless permission is granted by the Controlling Body to be in control of or train additional greyhounds for which they are able to provide Controlling Body and local council approved accommodation and facilities for.
- Has had at least 12 months experience as a trainer under a T3 or its equivalent in another racing jurisdiction.

Trainer Licence – T3:

- Permits a person to be in control of or train a maximum of three (3) greyhounds unless permission is granted by the Controlling Body to be in control of or train additional greyhounds for which they are able to provide Controlling Body and local council approved accommodation and facilities for
- Has experience in the form of at least 12 months experience as an Attendant or Owner or the equivalent thereof
 in another racing jurisdiction and hold a current licence
- Provide at least three references from persons within the greyhound industry, one of which must be a licensed greyhound trainer attesting to the applicant's skill, competency and general suitability to hold a Trainers licence.

A Trainer licence may be limited as to duration or locality or both. Subject to the previous clause every Trainer licence shall expire on the thirty-first day of July in each odd numbered year. Should a trainer be unable to attend a race meeting where any greyhound trained by him is engaged he shall nominate another licensed trainer or approved person to be responsible for such greyhound at the meeting. A trainer shall not, without having made written application and obtained the consent of the Stewards, kennel any greyhound trained by him or her in any location other than their registered kennel address as notified on this application or subsequent renewal.

A trainer must disclose and seek approval from the Controlling Body of all training venues/facilities that they wish to use. Where an initial application for a Trainer's licence is rejected, no further application shall be considered for a period of 6-months from the date of rejection of the first application, and a person who has had a second application for a Trainer's licence rejected within 12-months of the rejection of the initial application shall have no further application considered for a period of 12-months from the date of rejection of the second application, and should that or any subsequent application be rejected any further application shall not be considered for 12-months thereafter unless, the person is specifically invited to make application.

RWWA may refuse to consider any application for a Trainer's licence until it is satisfied that any direction or condition that it may require as a prerequisite to the granting of such licence has been satisfied.
